(2) Identical Confessions.4

(3) Declaration of a co-conspirator received without objection by the co-defendants.⁵

(4) Corroboration by other evidence.6

(5) Confession in the presence of a co-defendant implicating him who did not remonstrate will bind him?

Requisites for Admission

- (1) The conspiracy must first be proved by evidence other than such act or declaration;
- (2) The act or declaration must relate to the conspiracy, and
- (3) It must have been made during the existence of the conspiracy.

These three must concur.

To prove the first requisite, it is sufficient if a prima facie case is established.⁸

The phrase "The declaration must relate to the conspiracy" has been interpreted to mean "in aid or execution of the conspiracy".

The third requisite needs no explanation. Acts or declarations before or after the conspiracy are excluded. (Emiliano R. Navarro, Admission by Conspirator, 32 PHIL. L.J. R.A. No. 2034. An Act abolishing the barrio of Higatangan, Higatangan Island, Municipality of Naval, Province of Leyte, and creating instead the barrios of Libertad and Mabini in the same municipality.

R.A. No. 2035. An Act granting Zoilo E. Masculino a temporary permit to construct, maintain and operate private boat-to-shore and land mobile radio stations for the reception and transmission of radio communications within the Philippines.

R.A. No. 2036. An Act granting the Radio Communications of the Philippines a franchise to establish radio stations for domestic telecommunications.

R.A. No. 2037. An Act granting Mr. Ricardo P. Ocampo, resulting at number one hundred forty C. Francisco, Makati, Rizal, Philippines, a temporary permit to construct, install, establish and operate public radiotelephone and radiotelegraph coastal stations, with the corresponding relay stations, and public fixed and public base and land mobile stations for the reception and transmission of radiotelephone and radiotelegraph communications within the Philippines not at present served by public radiotelegraph and/or radiotelephone systems such as in lumber and mining concessions, farms, deep sea fishing and isolated concessions, farms, deep sea fishing and isolated municipalities.

R.A. No. 2038. An Act dividing the Municipality of Compostela, Province of Davao, into two municipalities, one to retain the name "Compostela," and the other to be known as the Municipality of Nabunturan.
