R.A. No. 1601. An Act to amend R.A. No. 1345, entitled "An Act creating the National Marketing Corporation and dissolving the Price Stabilization Corporation, appropriating funds therefor, and for other purposes:"

R.A. No. 1602. An Act to provide for the allocation, re-allocation and administration of quotas for cordage, buttons of pearl or shell, cigars, scrap and filler tobacco and coconut oil, and for other purposes.

R.A. No. 1603. An Act to amend section 4, Article 3, Chapter 1, section 5, Article 1, Chapter 2, and sections 12 and 14, Article 3, Chapter 2, of Act No. 3992, otherwise known as the Motor Vehicle Law, as amended.
