

## LEGISLATION

**POLITICAL LAW: LABOR.** — The Industrial Peace Act, Republic No. 875, as it is evident from the title of the Act, "An Act To Promote Industrial Peace," intends to create harmony between capital and labor. This purpose is sought to be achieved by eliminating friction through mutual and voluntary agreement. Republic Act 3350 seeks to amend a very important portion of the Industrial Peace Act namely, Paragraph (4), Subsection (a) of Section Four which allows an employer to make an agreement with a labor organization to require as a condition of employment membership therein, if the labor organization is the representative of the employees. Republic Act No. 3350 provides an exception to this proviso which is indicative of the respect that the Legislature has for the religion of the individual.

### REPUBLIC ACT NO. 3350

#### AN ACT AMENDING PARAGRAPH (4), SUBSECTION (a) OF SECTION FOUR OF REPUBLIC ACT NUMBERED EIGHT HUNDRED SEVENTY-FIVE.

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

SECTION 1. Paragraph (4), subsection (a) of section four of Republic Act numbered Eight Hundred Seventy-Five is hereby amended by providing an exception to the application of the proviso, and as amended should read as follows:

"(4) PROVIDED, that nothing in this Act or in any Act or statute of the Republic of the Philippines shall preclude an employer from making an agreement with a labor organization to require as a condition of employment membership therein, if such labor organization is the representative of the employees as provided in Section Twelve, but such agreement shall not cover members of any religious sects which prohibit affiliation of their members in any such labor organization."

SECTION 2. This Act shall take effect upon its approval.

Enacted, without Executive approval, June 18, 1961.
